

Sample authorization to download an Extended Company Report

Information for an entity applying to BIG InfoMonitor for disclosure of data

This is the wording of the company's sample authorization. We require it when you submit an application to disclose business information from Biuro Informacji Kredytowej S.A. and the Polish Bank Association.

Information for the company granting the authorization

You must fill out, sign and stamp the authorization if you agree that the entity to which you wish to give the following authorization will obtain business data on your company from Biuro Informacji Kredytowej S.A. and the Polish Bank Association. The purpose of such verification is to check the payment reliability of your company. The deletion of a specific consent results in the impossibility to retrieve information or data.

When you want to transfer your data, the controller will send them to you in a structured, widely used format suitable for machine reading. You can send them to another data controller.
