

**Information for an entity applying to BIG InfoMonitor for disclosure of data**

This is the wording of the consumer's sample authorization. We require it when you submit an application to acquire and disclose economic information from our Registry and economic information from Biuro Informacji Kredytowej S.A. [*Credit Information Bureau*] and the Polish Bank Association.

**Information for the consumer who is giving the authorization**

Fill out and sign the authorization if you agree for the entity which you wish to authorize to obtain business information about you from the BIG InfoMonitor Registry and business data from Biuro Informacji Kredytowej S.A. and the Polish Bank Association. The purpose of such verification is to check your payment reliability. The deletion of a specific consent results in the impossibility to retrieve information or data.

It will do that on the basis of your authorization.	BIG InfoMonitor, in order to: - disclose business information or verify data quality on order of the entity that you have authorized - in this way, it will pursue its justified interests as the data controller (this is the basis for processing your personal data); - disclose information about inquiries - it will do this on the basis of your consent (this is the basis for processing your personal data); - keep a Register of Inquiries, and thereby fulfil its obligation set forth in Article 27 of the Act on BIG.		BIK and ZBP, in order to: disclose economic data - thereby pursue its justified interests as the data controller (this is the basis for processing your personal data).	
6. The entity that you have authorized, BIG InfoMonitor, and ZBP process your: first name, last name, date of birth, or PESEL, number and series of identity document.					
7. Recipients of your personal data may be companies servicing ITC systems, or providing other IT services to the entity that you have authorized, BIG InfoMonitor, BIK, or ZBP. They obtain them only insofar as is necessary to pursue the goals for which these data are processed.					
8. You have the right to:					
a) access your data,					
b) demand rectification, removal, limitation of processing of your data,					
c) object to personal data processing – in the scope where the basis for processing is the legally justified interest of the controller,					
d) withdraw consent to personal data processing – in the scope where the basis for processing is your consent. The withdrawal of consent does not affect the lawfulness of the processing which was carried out on the basis of the consent before its withdrawal.					
e) transfer your personal data – in the scope in which the controller processes them based on your consent or for the performance of the agreement concluded with you. When you want to transfer your data, the controller will send them to you in a structured, widely used format suitable for machine reading. You can send them to another data controller. The right to transfer data does not concern data constituting the trade secret of the entity that you have authorized,					
f) file a complaint with a supervisory authority which deals with personal data protection.
